- Boston Housing Authority development, includes Section 8 housing
- Approximately 150 families smaller than most other BHA locations.
- Demographics by race/ethnicity according to on-site administrator
- Approx. 80% Spanish-speaking (black, white, Latino, mixed)
- Approx 10% Haitian
- Approx 10% other, including 1 Asian family, 2 Cape Verdean, and some White Families.
- (breakdown of ages, needs, etc. unavailable)
- Some violence/drugs during the pandemic (public safety meeting reports), but relatively quiet.

It is Civic Space's understanding that the main goal is to improve the aesthetic appeal of a streetscape plaza and parking lot at 125 South Main Street and to activate the Space and improve public safety for BHA residents, seniors, and visitors to the area. The site at 125 Main Street serves as the parking lot for residents living at BHA housing units, the Community Center that is attached to the building.

To successfully improve the space, BHA property management and residents must be engaged to help shape the overall design direction for the parking lot activation. Initial project meetings to further refine the scope would be set up with the following key stakeholders:

- The property owner and manager to discuss what is allowed or could be allowed on site.
- The Community Center staff to learn about their capacity to help engage participation from local residents and to manage the installation after project implementation.

Throughout the community engagement process, Civic Space will collect ideas from residents and visitors to Centre Street about how to activate the site. This information be collected into a set of guidelines that the site designer can use in the next phase to design the site. It is our understanding that JP Centre/South Main Streets has some funds available for implementation. Civic Space can work towards recommending design solutions that are within the existing budget, as well as help to identify additional funds.

First Step: Boston Housing Authority

- Started with contact with Boston Housing Authority staff and administration
- June 27, 2023 site visit with apartment administrator, BHA Maintenance (local and regional), Assistant Director of Property Management (regional), Chief of Media and Engagement for BHA, BHA Chief of Staff/Chief Procurement Officer.
- Cautious but optimistic cooperation



South Street Youth Center Engagement

 "Project Manager for CSC (and faculty member at Olin College of Engineering where he teaches human-centered design) will lead the students through a design process to analyze the current conditions of the site, brainstorm a range of ideas, narrow to the most desirable, and present them to the JP Main Streets Design Team."





Surprising revelations from the youth:

- "There is a lot of overgrown plants"
- It's hot out there
- Parking lot paint is old and faded (speed bumps and parking spots)
- "I learned that there used to be weekly events that used to happen here"
- "I learned that after COVID the community started to drive away"
- "There are never kids outside"
- People move around and in and out so it's hard to get to know the community
- People don't hang out as much






Survey Results – March 2024


Presentation of Results – April 2024

Lessons Learned

- Youth are often an overlooked perspective, but they are the continuation of anything that's built, so their involvement and understanding is crucial for long-term success.
- Google Translate is actually pretty good for Spanish.
- Building trust is essential. In marginalized communities, there can be a tendency to tell you what you "want to hear." Craft your survey carefully to avoid the appearance of "right answers." Engage OFTEN and persistently, and qualitative answers (one-on-one conversations) may be more forthcoming than quantitative answers.
 - Be aware of distrust of authority. Many of the tenants were afraid to speak against the BHA.

Finally, be prepared to have tough conversations.
